Accordingly, the final aggregate amount raised by the Company from the 3-month Series 005 SDAX Issuance is S\$12.06 million. The digital securities to be issued by the Company to the subscribers of the 3-month Series 005 SDAX Issuance will be issued on the SDAX Platform on 19 December 2024, and will mature on 20 March 2025.
