The Board of Directors (the "**Board**") of CSC Holdings Limited (the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce that the Company has today launched the fifth series of its 3-month commercial paper in digital securities under the SDAX CP Facility Programme ("**3-month Series 005 SDAX Issuance**").

The 3-month Series 005 SDAX Issuance is priced at an interest rate of 5.3% per annum and matures approximately three (3) months from the date of issuance.

The Company expects to raise between S\$5 million and S\$8 million from accredited investor(s) and institutional investor(s) under the 3-month Series 005 SDAX Issuance.

The Company will make further announcements as and when there are material developments in respect of the SDAX CP Facility Programme and the 3-month Series 005 SDAX Issuance.
