Transfer of 341,825,771 shares held by TH Investments Pte Ltd ("THI") to a nominee account under HSBC (Singapore) Nominees Pte Ltd.

THI is a wholly owned subsidiary of Chwee Cheng & Sons Pte Ltd ("CCSPL").

In addition, Mr Ng Chwee Cheng ("NGCC"), the father of Mr Ng San Tiong ("NST") who is a director of CSC Holdings Limited ("CSC"), owns a total of 50,706,500 representing 4.14% of the issued share capital (excluding treasury shares of 6,870,000 shares) of CSC of 1,223,373,725.

THI together with NST and NGCC holds 32.65% of the issued share capital of CSC.
