Pursuant to CSC Holdings Limited's Rights cum Warrants Exercise (the "Rights Issue"), Maybank Kim Eng Securities Pte Ltd has subscribed for all their Rights Shares Entitlement of 166,666 Rights Shares, for Mr Ng San Tiong's benefit. Each Rights Share comes with five free Warrants, with each Warrant carrying the right to subscribe for one Warrant Share at the Exercise Price of S\$0.01 per Warrant Share. Accordingly, Maybank Kim Eng Securities Pte Ltd has been issued 833,330 Warrants arising from the Rights Issue.

TH Investment Pte Ltd ("THI") is a wholly-owned subsidiary of Tat Hong Investments Pte Ltd, which is a wholly-owned subsidiary of Chwee Cheng & Sons Pte Ltd. 42.03% of the issued share capital of Chwee Cheng & Sons Pte Ltd is owned by the Chwee Cheng Trust (constituted under trust deed). Being joint trustees of Chwee Cheng Trust, Mr Ng San Tiong, along with Chwee Cheng & Sons Pte Ltd and Tat Hong Investments Pte Ltd, is deemed to be interested in the shares held by THI in CSC Holdings Limited.

Pursuant to CSC Holdings Limited's Rights Issue, Raffles Nominees Pte Ltd has subscribed for all their Rights Shares Entitlement of 114,941,923 Rights Shares, for THI's benefit. Each Rights Share comes with five free Warrants, with each Warrant carrying the right to subscribe for one Warrant Share at the Exercise Price of S\$0.01 per Warrant Share. Accordingly, Raffles Nominees Pte Ltd has been issued 574,709,615 Warrants arising from the Rights Issue.

Mr Ng San Tiong is deemed interested in the total Warrants of 575,542,945 issued to both Maybank Kim Eng Securities Pte Ltd and Raffles Nominees Pte Ltd.
