Pursuant to CSC Holdings Limited's Rights cum Warrants Exercise (the "Rights Issue"), HSBC (Singapore) Nominees Pte Ltd has subscribed for all their Rights Shares Entitlement of 2,116,666 Rights Shares, for Mr See Yen Tarn's benefit. Each Rights Share comes with five free Warrants, with each Warrant carrying the right to subscribe for one Warrant Share at the Exercise Price of S\$0.01 per Warrant Share. Accordingly, HSBC (Singapore) Nominees Pte Ltd has been issued 10,583,330 Warrants arising from the Rights Issue.
