TH Investment Pte Ltd ("THI") is a wholly-owned subsidiary of Tat Hong Investments Pte Ltd, which is a wholly-owned subsidiary of Chwee Cheng & Sons Pte Ltd. Being joint trustees of the Chwee Cheng Trust, Mr Ng is deemed to be interested in 344,825,771 ordinary shares of the Company held by THI. All shares of THI is held through Raffles Nominees Pte Ltd.

Accordingly Mr Ng is deemed interested in the Rights and Warrants Issue provisionally allotted to Maybank Kim Eng Securities Pte Ltd and Raffles Nominees Pte Ltd.
