The Board of Directors (the "**Board**") of CSC Holdings Limited (the "**Company**" and together with its subsidiaries, the "**Group**") is pleased to announce that the 3-month Series 012 SDAX Issuance and the 6-month Series 010 SDAX Issuance, both launched on 2 September 2026 has closed today at 11:30 a.m. (Singapore time) and has received strong demand from investors.

In respect of the 3-month Series 012 SDAX Issuance, the Company raised S\$2.74 million. The digital securities to be issued by the Company to the subscribers of the 3-month Series 012 SDAX Issuance will be issued on the SDAX Platform on 16 September 2026, and will mature on 17 December 2026.

In respect of the 6-month Series 010 SDAX Issuance, the Company raised S\$4.90 million. The digital securities to be issued by the Company to the subscribers of the 6-month Series 010 SDAX Issuance will be issued on the SDAX Platform on 16 September 2026, and will mature on 17 March 2027.
