LAUNCH OF SERIES 012 OF 3-MONTH COMMERCIAL PAPERS AND SERIES 010 OF 6-MONTH COMMERCIAL PAPERS IN DIGITAL SECURITIES ON THE DIGITAL SECURITIES PLATFORM SDAX

The Board of Directors (the "**Board**") of CSC Holdings Limited (the "**Company**" and together with its subsidiaries, the "**Group**") wishes to announce that the Company has today launched:

- the twelfth series of its 3-month commercial paper in digital securities under the SDAX CP Facility Programme ("**3-month Series 012 SDAX Issuance**"); and
- the tenth series of its 6-month commercial paper in digital securities under the SDAX CP Facility Programme ("**6-month Series 010 SDAX Issuance**").

The 3-month Series 012 SDAX Issuance is priced at an interest rate of 3.95% per annum and matures approximately three (3) months from the date of issuance. The 6-month Series 010 SDAX Issuance is priced at an interest rate of 4.50% per annum and matures approximately six (6) months from the date of issuance.

The Company expects to raise an aggregate of between S\$6 million and S\$8 million from accredited investor(s) and institutional investor(s) under the 3-month Series 012 SDAX Issuance and 6-month Series 010 SDAX Issuance.

The Company will make further announcements as and when there are material developments in respect of the SDAX CP Facility Programme, the 3-month Series 012 SDAX Issuance and the 6-month Series 010 SDAX Issuance.
