39.5% OF THE ISSUED SHARE CAPITAL OF CCSPL IS OWNED BY THE CHWEE CHENG TRUST CONSTITUTED UNDER A TRUST DEED.

AS A JOINT TRUSTEE OF CHWEE CHENG TRUST AND BY VIRTUE OF THE CHWEE CHENG TRUST'S INTEREST IN CCSPL, MR NG SAN TIONG ROLAND IS DEEMED TO BE INTERESTED IN ALL THE SHARES HELD BY THIPL IN CSC.

MR NG SAN TIONG ROLAND ALSO OWNS 0.856% INTEREST IN CSC THROUGH HIS NOMINEE ACCOUNT.
