CSC SECURES ADDITIONAL \$50M WORTH OF FOUNDATION CONTRACTS FOR LNG TERMINAL AND 3 MORE MRT STATIONS

SINGAPORE, 12 April 2010 – Further to the announcement on 8 March 2010, mainboard-listed foundation and geotechnical engineering specialist **CSC Holdings Limited (“CSC” or the “Group”)**, has clinched contracts worth more than \$50 million for foundation works to be carried out for Singapore’s very first liquefied natural gas (LNG) terminal, along with the King Albert Park, Sixth Avenue and Tan Kah Kee MRT Stations along the new Bukit Timah Line.

The new contracts were secured following the Group’s announcement of contract wins worth more than \$70 million a month ago. With this latest addition, CSC’s order book now stands in excess of \$180 million.

CSC will be installing more than 5,000 driven piles consisting of steel pipe piles and spun piles. The billion-dollar LNG Terminal is to be operated by the Singapore government and is located on a 30-hectare site on Jurong Island. It is targeted to commence operations in 2013. There is a possible expansion of the facilities which may result in the installation of additional piles.

As for the MRT Stations, the Group has been engaged to construct diaphragm walls and secant pile walls for the underground station structures.

Mr See Yen Tarn (薛献凡), Group CEO of CSC Holdings said, “With the addition of these new MRT projects, our Group is now handling foundation works for 4 out of 12 stations along the Bukit Timah MRT Line. As the only local diaphragm wall specialist and a leading large diameter bored pile specialist in Singapore, we look forward to contributing our expertise in this area.”
