CSC WINS FASTEST GROWING 50 AWARD FOR 2nd YEAR RUNNING

SINGAPORE, 31 August 2010 – Foundation and geotechnical engineering specialist, **CSC Holdings Limited** has been certified for the second year running, as one of Singapore's 50 fastest growing companies by DP Information Group, a leading provider of business and credit information. Amongst the winners for the FG50 award this year were companies generating sales in excess of S\$1 billion.
