DEREGISTRATION OF L&M FOUNDATION SPECIALIST (MIDDLE EAST) LLC

The Board of Directors (the "Directors") of CSC Holdings Limited (the "Company") wishes to announce that its 49% owned subsidiary, L&M Foundation Specialist (Middle East) LLC ("LMME") has been deregistered.

LMME was incorporated in September 2008. Due to the unfavourable economic conditions brought about by the onset of the global financial crisis in October 2008, LMME had remained dormant since incorporation. Following this the Directors of the Company had applied to deregister LMME. The Company had obtained approval and clearance from the government authorities of Abu Dhabi, United Arab Emirates ("UAE") for the said deregistration.

At the date of deregistration, the net tangible assets ("NTA") of LMME was nil UAE Dirham. The deregistration of LMME will not have any material impact on the consolidated earnings and consolidated NTA per share of the Company for the current financial year.

None of the Directors (other than in their capacity as a director or shareholder of the Company) or controlling shareholders of the Company has any interest, direct or indirect, in this transaction.
